




What to do next...

How we can help

Please be aware that there are certain procedures that must be followed when fundraising. If you are unsure about any aspect of fundraising legalities, please contact us and we will be happy to help.

If you would like to hold a street collection, you must have a permit from the local council. Raffles are an excellent way of raising funds, however there are certain ticketing regulations with which you must comply. Please contact us if you are planning to hold a raffle and we can advise you on how to proceed.

Do you need a license? A Temporary Event License is required for all forms of entertainment e.g. sale/provision of alcohol, provision of food or drink, performance of live music, any playing of music, performance of a play or indoor sporting event etc. Please contact your local council for more information and how to apply.
